Special Called Meeting Minutes for June 29, 2021 7:30 ET

The Special Called Meeting of the Irvington City Council was called to order by Mayor Yvonne Kennedy. Prayer was by Mayor Kennedy followed by the Pledge to the American Flag.

Council Members Ronnie Robinson, Robert Young III, Bruce Basham, Charles Douglas Lucas and Pat Logsdon were in attendance. Council Member Ricky Lucas was absent.

Mayor Kennedy read Ordinance 2020-8.2 An Ordinance Adopting the City of Irvington, Second Amended annual Budget For Fiscal Year July 1, 2020 Through June 30, 2021 By Estimating Resources and Appropriating Funds for the Operation of City Government.

Bruce Basham moved to accept the first reading of Ordinance 2020-8.2. Motion was seconded by Charles Douglas Lucas. A roll call vote was taken with Council Members Bruce Basham, Pat Logsdon, Ronnie Robinson, Robert Young III and Charles Douglas Lucas voting affirmation. Motion carried.

Mayor Kennedy read Ordinance 2021-6, An Ordinance Adopting the City of Irvington, Annual Budget for Fiscal Year of July 1, 2021 through June 30, 2022 By Estimating Resources and Appropriating Funds for the Operation of City Government.

Bruce Basham moved to accept the first reading of Ordinance 2021-6. Motion was seconded by Ronnie Robinson. A roll call vote was taken with Council Members Bruce Basham, Ronnie Robinson, Robert Young III and Pat Logsdon voting in favor of Ordinance 2021-6 and Charles Douglas Lucas voting against the ordinance. Motion carried.

Mayor Kennedy read Ordinance 2021-7, An Ordinance increasing Water Rates for the City of Irvington. Ronnie Robinson moved to accept the first reading of Ordinance 2021-7. Motion was seconded by Pat Logsdon. A roll call vote was taken with Council Members Bruce Basham, Ronnie Robinson, Robert Young III and Pat Logsdon voting in favor of Ordinance 2021-7 and Charles Douglas Lucas voting against the ordinance. Motion carried.

Mayor Kennedy read Ordinance 2021-8, An Ordinance Increasing Sewer and Wastewater Charges and Rates for the City of Irvington. Council Member Bruce Basham moved to accept the first reading of Ordinance 2021-8. Motion was seconded by Pat Logsdon. A roll call vote was taken with Council Members Bruce Basham, Ronnie Robinson, Robert Young III and Pat Logsdon voting in favor of Ordinance 2021-8 and Charles Douglas Lucas voting against the ordinance. Motion carried.

A special called meeting was set for Wednesday, June 30 at 7:00 pm ET for the second reading of these ordinances.

Bruce Basham moved to adjourn the meeting. The motion was seconded by Charles Douglas Lucas. All council member voted in the affirmative and the meeting was adjourned.
